• **Eligibility** —→ **All media, original work and design only.**

Good craftsmanship is expected. No kits, t-shirts, or commercially manufactured goods. The work must be your own, not copied, only two media per space, please. Each must be juried.

Send FOUR slides or digital images on a CD, THREE of current individual pieces, close-up, showing details, ONE of your booth. Prints will not be accepted. Mark slides with your name and indicate top (↑) for viewing. Images will be returned at the Festival. Send self-addressed, stamped envelope for jury notification.

• **Rules** —→ **Artists must be present at the show.**

No pets, alcoholic beverages, or drugs, please. The Festival Committee will not be responsible for loss or damages. Those not complying with all of the rules will be asked to leave, and may not be allowed to participate in the future. Michigan State sales tax information will be available.

• **Set-up** —→ **Begins at 7 a.m.** 10'x10' spaces will be assigned. Please bring your own display materials. Booths must be secured with weights or stakes. Unloading space and time are limited. Spaces not claimed by 9:00 a.m. will be reassigned. Displays must remain in place until 5 p.m. **No vehicles for packing up allowed on site before 5 p.m.**

• **Parking** —→ **A courtesy tag for parking is mandatory.** The tag must be displayed in your windshield. Vehicle must be moved to the designated parking area immediately after unloading. No unauthorized parking in the handicap area.

• **Entry Fee** —→ **\$75.00 booth fee and \$5.00 non-refundable jury fee.** Please send two separate checks made payable to "Festival of Arts". No booth fees refunded for cancellation after July 15th. Booth fee will be returned, if not accepted.

Deadline —→ **Postmarked by March 15** to be considered for jury. Notification by May 1.
